JEPB Rule 2 Rulemaking 2019 – Adoptions of federal and state rules

Adopted by **JEPB Rule 2.201**

DEP Summary - The rule amendments update the Department's adoption-by-reference of air pollution regulations promulgated by the U.S. Environmental Protection Agency (EPA) at 40 C.F.R. Parts 551, 52, 60, 62, 63, and 81 to incorporate requirements of the Department's federally approved and delegated air pollution programs.

Rules 62-210.200, 62-210.300, 62-210.310, 62-210.550 and 62-210.900, F.A.C. Stationary Sources – General Requirements

FAC Rules 62-210.200, 62-210.300, 62-210.310, 62-210.550 and 62-210.900 [DEP OGC 17-0890]

Rule Amend. Effective 7/3/18

Adopted by **JEPB Rule 2.301**

DEP Summary - Stationary Sources – General Requirements – Rules 62-210.200, 62-210.300, and 62-210.310, F.A.C. The purpose of the amendment is to clarify existing language and amend paragraph 62-210.300(3)(a), F.A.C. to allow for the continued exemption from permitting for fossil fuel steam generators, hot water generators, and other external combustion heating units with heat input capacity less than 100 million Btu per hour. Amendments would, in part, update the permitting exemption for sources that meet the requirements in 40 CFR Part 63 Subpart JJJJJJ (National Emission Standards for Hazardous Air Pollutants for Industrial, Commercial, and Institutional Boilers Area Sources). Amendments will also revise Rule 62-210.310, F.A.C., to clarify the circumstances under which temporary and relocatable sources, including emissions units operating under an Air General Permit (AGP), may collocate at otherwise permitted facilities without permit revisions. The revisions also update the AGP for Chromium Electroplaters to reflect updates to 40 CFR Part 63 Subpart N. Also, amendments clarify and correct revisions to existing rule language in Rules 62-210.200, 62-210.300, 62-210.310 and 62-210.550, F.A.C.

DEP Summary - Stationary Sources – General Requirements - Rule 62-210.900, F.A.C. The purpose of the rule is to revise and update Rule 62-210.900, F.A.C., to update three of the Division's forms. The instructions to the Annual Operating Report for Air Pollutant Emitting Facility and the instructions to two air permit application forms each contain an appendix of pollutant identification codes. As new federal regulations for additional pollutants have been promulgated, the appendices have been updated to include these pollutants in the list of pollutant identification codes, to clarify existing language, and to make the list of pollutant identification codes the same for each of the three forms. In addition, the rule clarifications facilitate the completion and processing of these three forms. The Department is also providing links to the other forms that have not been updated in Rule 62-296.900, F.A.C., in order to provide consistency.
